



Arts in the Parks




The Board of Supervisors established a community funding pool for arts and cultural organizations serving residents of Fairfax County through a grant to the Arts Council of Fairfax County.

- 3. Utilizing the County's Office of Public Private Partnerships to explore arts Partnerships.
- 4. Created a list of all venues currently used for the arts in the County, this list included location, uses,

- venue condition, availability and other information. A list of school sites was also created.
- 5. Created a GIS map to show where the existing facilities are located and where facilities might be needed.
- 6. Public art language was incorporated into the Springfield Town Center Proffers.
- 7. Drafted Policy Plan Amendment Strawman for the Visual and Performing Arts reviewed by the DPZ management team July 21<sup>st</sup>.
  - 1). Support opportunities to display visual art in public places, private development and public-private ventures.
  - 2). Seek investment in existing and new arts facilities through the provision of proffers, conditions, contributions and land dedication.
  - 3) Provide for a variety of arts venues to accommodate audience and performance space needs and technical capabilities.
  - 4) Mitigate the impact of new (or, in some cases, renovation of) arts facilities on surrounding land uses, environmental, transportation and public infrastructure.
